### LAYA IS ASSISTANT B.A. DEAN

### ECONOMICS SOCIETY OFFERS FELLOWSHIP

The U.P. Economics Society has announced that it is offering a fellowship consisting of one semester's tuition beginning the first semester, 1967-68.

To qualify for this award, an applicant must be an economics major who is at least in his junior year either in the College of Business Administration or the College of Arts and Sciences. He must have carried an academic load of not less than 15 units the previous semester, with a weighted average not lower than 2.25. This must include not less than 6 units of economics courses with an average grade in these courses of at least 1.75. In addition, the applicant must not have been subject to any disciplinary action in the past.

Qualified applicants will be given a competitive examination which will be the final basis for selection. The grantee will automatically be qualified for membership in the Economics Society.

# THIRD TRAINING PROGRAM IN DEVELOPMENT ECONOMICS BEGINS

The U.P. School of Economics started its Third Training Program in Development Economics last July 10 with 28 trainees who will undergo training for a period of six months.
